The objects of the trust are- (1) Education:- to help and assist financially educational institutions, to give scholarships, assistance by way of tuition fees to deserving poor students irrespective of class or community, sex, creed etc; to construct and run hostels for the students and to establish and run educational institutions and run reading room and libraries. (2) Poor relief:- to establish and run houses for the poor, to give assistance by way of food and other maintenance to poor children of all castes, creed and sex without any distinction. (3) Medical Relief:- to establish and run free dispensaries, clinics, to give medical assistance, free supply of medicines to poor patients of all class, creed, sex or community without any distinction. 6. The parties hereto, who are the first trustees are empowered to co-opt trustees so that the total number of trustees at any time does not exceed nine. Each of the first trustee is entitled to nominate any person as his/her successor to to the office of the trustee. In the event of any vacancy arising in the office of the trust, the continuing trustees may or ^(v) ~~may~~ not co-opt ^(v) ~~other~~ trustees so however that the number of trustees shall not be ^(v) ~~less~~ less than three. 7. The trustees at their desire discretion may receive voluntary contributions by way of gifts/grants from the public either in the form of cash or investment towards the corpus of the trust, or towards the capital expenditure of the trust and the same when required, shall become part and parcel of the trust fund. 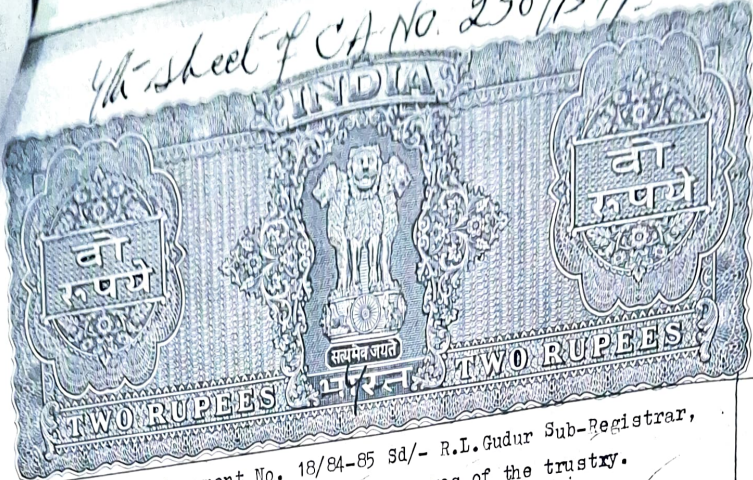

under section 80 G of the Income-tax Act, 1961. (r) To frame rules in conformity with the above, powers to vary them and do all other acts or things as are incidental conducive and expedient to the attainment of the objects of the Trust. 11. The trustees shall apply the funds and properties of the trust (corpus and income inclusive) for all or any of the objects for which this trust is established. Subject as aforesaid the trustees shall have absolute discretion in the matter of management of the funds, properties and affairs of the trust in the matter of exercise of various powers conferred on the trust and in the matter of regulating how much and to what particular purpose the funds and properties of the trust shall be applied from time to time. And no action of the trustees shall be questioned or invalidated on the ground that the said powers and discretions have been exercised imprudently.

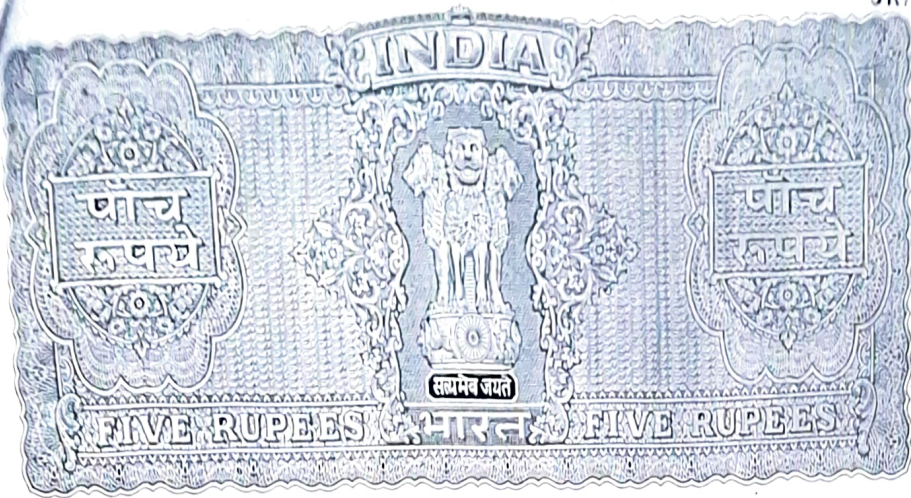
